1. PRICES AND PERIOD OF PERFORMANCE

The Contractor shall perform garbage disposal services, including furnishing all labor, material, equipment and services, for the U.S. Embassy in Santo Domingo and US Government controlled properties in Santo Domingo. The price listed below shall include all labor, materials, insurance (see FAR 52.228-4 and 52.228-5), overhead, and profit. The Government will pay the Contractor the fixed price per month for standard services and a fixed per pick-up for any temporary additional services that have been satisfactorily performed.

After contract award and submission of acceptable insurance certificates, the Contracting Officer shall issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from start date listed in Notice to Proceed unless the Contractor agrees to an earlier date) on which performance shall start.

Temporary Additional Services (TAS) are requirements defined as Standard Services but that may be required at times other than the normal workday. These services shall support special events and/or unscheduled requirements at Post. The Contractor shall provide Temporary Additional Services in addition to the scheduled services specified in this contract. The Contracting Officer's Representative (COR) shall order Temporary Additional Services on an as needed basis. This work shall be performed by Contractor-trained employees, and shall not be subcontracted. The Contracting Officer's Representative (COR) may require the Contractor to provide Temporary Additional Services with twenty-four (24) hour notice.

The Contractor shall issue separate invoices for any Temporary Additional Services (TAS) and, if applicable, materials, provided and requested under TAS. The Contractor shall also include a copy of the COR's written confirmation, and the task order, for any billed Temporary Additional Services (TAS).

Because Temporary Additional Services (TAS) are based on Indefinite Delivery/Indefinite Quantity (IDIQ), the minimum and maximum amounts are defined below:

Minimum: The Government shall place Task Orders for Temporary Additional Services (TAS) totaling a minimum of two (2) occurrences. This reflects the contract minimum for each year of the Contract.

Maximum: The amount of all Task Orders for Temporary Additional Services (TAS) shall not exceed forty (40) occurrences. This reflects the contract maximum for each year of the Contract.

The performance period of this contract is from the start date in the Notice to Proceed and continuing for 12 months, with three (3) one-year options to renew, exercised at the discretion of the U.S. Government (USG). The initial period of performance includes any transition period authorized under the contract.

For satisfactory performance of all scheduled services required under this Contract, the Government shall pay the Contractor a Firm-Fixed-Price per unit of service in Dominican Pesos (DOP\$).

1.1 VALUE ADDED TAX

VALUE ADDED TAX. Value Added Tax (VAT) is not applicable to this contract and shall not be included in the CLIN rates or Invoices because the U.S. Embassy has a tax exemption certificate from the host government.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. SCOPE OF WORK

The purpose of this fixed price contract is to obtain garbage disposal services for real property owned or managed by the U.S. Government for US. Embassy in Santo Domingo. The Contractor will furnish all material, equipment, supplies and personnel to provide solid waste collection and disposal service for the U.S. Embassy in Santo Domingo, Dominican Republic. The Contractor will also be required to manage, supervise and inspect the service properly.

The Contractor shall furnish all managerial, administrative, and direct labor personnel that are necessary to accomplish the work in this contract. Contractor employees shall be on site only for contractual duties and not for other business purposes.

Services include pick-up of solid waste at the following four locations in Santo Domingo, Dominican Republic:

Chancery Building (CB)	57 República de Colombia; Arroyo Hondo II
Chief of Mission Residence (CMR)	14 Leopoldo Navarro; Gazcue

Los Bambues Residences (LB)	Calle Paseo Los Bambues, Residencial Los Bambues, Arroyo Hondo

Services also include cleaning of the inside and outside of garbage collection bins and the surrounding areas, as well as the proper disposal of collected garbage.

2. SCHEDULE OF SERVICES

a. Frequency of pick-ups shall be:

- CB – Daily during weekdays. The Embassy reserves the right to request a special pick-up after a special event. With the exception of special events, the Contractor shall not be required to pick-up garbage on Dominican or American holidays. As requested will pick-up the recycling.
- CMR – Daily during weekdays. The Embassy reserves the right to request a special pick-up after a special event. With the exception of special events, the Contractor shall not be required to pick-up garbage on Dominican holidays. As requested will pick-up the recycling.



- DCMR – Three days a week, Monday/Wednesday/Friday. The Embassy reserves the right to request a special pick-up after a special event. With the exception of special events, the Contractor shall not be required to pick-up garbage on Dominican holidays. As requested will pick-up the recycling.
- LB – Daily during weekdays. The Embassy reserves the right to request a special pick-up after a special event. With the exception of special events, the Contractor shall not be required to pick-up garbage on Dominican holidays. As requested will pick-up recycling.

b. Hours of Pick-up shall be:

The Contractor shall empty the dumpsters at the following times of day for each location.

- CB – Between 0700 and 1645.
- CMR – Between 0800 and 1645.
- DCMR – Between 0800 and 1645.
- LB – Between 1200 and 1645.

The Contracting Officer shall notify the Contractor in writing of any significant changes to the pick-up schedule.

### 3. CONTRACTOR FURNISHED PROPERTY

The Contractor shall provide all necessary supplies and equipment to perform the work identified in this contract. Refer to Attachment 1 for a list of the minimum materials, equipment, supplies and work clothing to be supplied.

The Contractor shall furnish a full list of products it proposes to use at the time of bid submission.

#### 3.1 DUMPSTERS.

The contractor shall furnish new straight-sided containers as requested by the COR, hereinafter referred to as dumpsters, which will hold bagged garbage. Each dumpster must have a metal top lid and a sliding door on each side. Each dumpster must be large enough to accept at least 1,100 liters of garbage and other waste materials.

Dumpsters must be closed at all times for sanitary reasons. The Contractor shall take care to maintain the dumpsters so that they give a good appearance and do not appear rusty or damaged. If the Government feels a dumpster is unserviceable, the Contracting Officer's Representative will request that it be replaced. If the Contractor disagrees, a meeting on site with the Contracting Officer and the Contractor shall be scheduled to inspect the questioned dumpster and resolve the situation. The CO will make the final determination of whether the dumpster should be replaced, after inspecting the dumpster with the Contractor.

Dumpster replacements will be separately priced out by the Contractor for the Government's approval and acceptance. The Government has the option to accept or

reject the Contractor's quote for dumpsters and reserves the right to obtain similar dumpsters from other competitive sources. If required by the Government, the Contractor shall utilize Government-purchased dumpsters, if awarded the work. Dumpster's replacements shall be complete via a separate purchase order. However, this exclusion does not apply if the replacement is being done due to damage caused by Contractor negligence.

The contractor shall have five (5) business days to replace the dumpsters upon receipt of a Purchase order. The contractor is responsible for the removal and disposal of the damaged dumpsters at no extra cost to the Government.

Dumpster replacement check list:

- Do the container have a lid that keeps rainwater out and keeps material from getting wet? Yes\_\_ No\_\_
- Does the container have any holes (any hole larger the ¼ of an inch) that allow the penetration of vermin or animals to its interior? Yes\_\_ No\_\_
- Has the container been damaged in the Trash pickup up operations and is now deformed or has cracks or are any of its movable parts broken (e.g. Wheels, handles or hinges)? Yes\_\_ No \_\_
- Any other instances which violate OSHA requirements or Dominican Laws. Yes\_\_ No\_\_ (specify)\_\_\_\_\_

If any of these questions are affirmative, the COR will ask for the replacement of the container.

### 3.1.1 Location, Quantity and Size of Dumpsters

The locations, quantities and sizes of the dumpsters to be provided for each site are as follows:

Location	Quantity	Size
CB	As requested by the COR. One (1) to twenty (20) or as many as can be safely and comfortably fit the available space.*	Each dumpster must be large enough to accept at least 1,100 liters of garbage and other waste materials
CMR	As requested by the COR. One (1) to three (3) dumpsters.

LB	As requested by the COR. One (1) to six (6) dumpsters or as many as can be safely and comfortably fit the available space. *

The dumpsters in each location are currently distributed as follows: twenty (20) units at the CB, three (3) units at DCMR, three (3) units at CMR, and six (6) units at LB. They should be provided by the contractor as requested and shall be at least a capacity of one thousand one hundred liters (1,100) each one.

### 3.2 VEHICLES.

Contractor vehicles used in the performance of the contract work shall have leak proof bodies. The Contractor shall replace the seals on the garbage holding units regularly or as required to prevent leakage on Government property. The Contractor shall maintain all vehicles in a neat, clean, orderly and sanitary condition. The Contractor shall identify each vehicle by decal or other marking(s). The Contractor shall provide to the Government a list of all vehicles to be used for this contract, including make/model/color/license plate number according to the Deliverables schedule.

### 3.3 EQUIPMENT AND CLEANING MATERIALS.

The Contractor shall supply all equipment and cleaning materials, including but not limited to the list found in Attachment 1. The Contractor shall use only Government-approved chemical products and shall store all chemical products properly.

## 4. CONTRACTOR RESPONSIBILITIES

The Contractor shall be responsible to perform the following duties:

- Empty the dumpsters
- Close the dumpster lids and clean the area around each dumpster
- Clean the dumpsters inside and out
- Dispose of garbage properly
- Use Government-approved chemical products and store them properly
- Keep accurate records
- Observe laws and good safety practices

The Contractor shall empty the dumpsters at each location following the schedule define in Schedule of Services.

The Contractor shall close the lid after every pickup and clean the area around each dumpster at every pickup. The Contractor shall be responsible for picking up any trash dropped by collection personnel at the collection site, or at the truck location or between the collection site and the truck location. The Contractor shall supply all materials and tools for cleaning of debris.

The Contractor shall clean each dumpster inside and out, one time per week, with soap and water. The Contractor shall deodorize each dumpster with a Government-approved product on a weekly basis. The Contractor shall disinfect each dumpster, and the area around it, with a Government-approved product on a monthly basis.

Services also include cleaning of the inside and outside of all recycling containers (up to forty (40)) and the surrounding areas, as well as the proper disposal of collected garbage.

The Contractor shall dispose of garbage properly in a legitimate, official, garbage disposal area. The Contractor shall immediately retrieve any loose material spilled from any vehicle, whether on or off U.S. Government property.

The Contractor shall observe all local health, safety and traffic laws. The Contractor shall keep written files of all pickups and all information concerning work- related accidents on Government property.

#### 4.1 MANAGEMENT AND SUPERVISION

The Contractor is responsible for coordination and supervision of all activities under this contract.

The Contractor shall designate a representative who will be responsible for managing work under this contract, including delegating requests along with any instruction required, and ensuring smooth and effective operations of Contractor personnel and equipment at all times. The account manager shall be the focal point for the Contractor and shall be the point of contact with U.S. Government personnel. This person shall have sufficient English language skill to be able to communicate with members of the U.S. Government.

Contractor personnel will be required to sign in each time they visit a property. The COR will monitor the sign-in sheets.

The Contractor shall protect the property from all potential hazards. The Contractor shall adhere to and enforce all applicable local safety regulations. The Contractor shall provide safety barriers, as required, to clearly identify the working area and to prevent others from accessing the work area. The safety zone shall be sufficiently sized to prevent damage to others or to existing facilities and structures. Upon completion of the work, the Contractor shall remove the safety barriers from the work area. Any accidents, injuries, fires or other incidents of a serious nature or incidents requiring emergency response must be reported immediately to Post One or Embassy Security Personnel.

The Contractor shall protect rivers and drainage ditches from chemical contamination, sediment run-off, construction debris, and other damage. Soil erosion and sediment control provisions and maintenance in accordance with local requirements are required. In the case of a spill or release of any sort, the Contractor shall immediately notify the COR.

The Contractor shall confine activities to the immediate work site. The Contractor shall not unreasonably encumber the work area with materials or equipment.

## 5. ACCESS TO GOVERNMENT BUILDINGS AND STANDARDS OF CONDUCT

5.1 General. The Contractor shall designate a representative who shall supervise the Contractor's personnel and be the Contractor's liaison with the U.S. Embassy Santo Domingo. This designate representative should be fluent in English, writing and speaking. The Contractor's employees shall be on-site only for contractual duties and not for any other business or purposes. Contractor employees shall have access to the designated disposal areas, either with or without security escorts, only with specific permission by either the Contracting Officer or the COR.

5.2 Personnel Security. The Government reserves the right to deny access to U.S owned and U.S.-operated facilities to any individual. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall be used on this contract prior to their utilization. The Government shall issue identity cards to approved Contractor personnel, each of whom shall display his/her card(s) on the uniform at all times while on Government property, or while on duty at private residences serviced under this contract. These identity cards are the property of the Government. The Contractor shall return all identity cards when the contract is completed, when a Contractor's employee leaves this contract, or at the request of the Government.

### 5.3 Standards of Conduct

5.3.1 General. The Contractor shall maintain satisfactory standards of employee competency conduct cleanliness, appearance and integrity and shall be responsible for taking such disciplinary action with respect to employees as may be necessary. Each Contractor employee shall adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

5.3.2 Uniforms and Personal Equipment. The Contractor's employees shall wear clean, neat and complete uniforms when on duty. The Contractor shall provide, to each employee and supervisor, uniforms and personal protection equipment. The Contractor shall be responsible for the cost of purchasing, cleaning, pressing, and repair of the uniforms.

5.3.3 Neglect of duties shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personal affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the worksite security.

5.3.4 The Contractor shall not condone disorderly conduct, use of abusive or offensive language, quarreling, and intimidation by words, actions, or fighting. Also included is

participation in disruptive activities that interfere with normal and efficient Government operations.

5.3.5 Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances which produce similar effects.

5.3.6 Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These circumstances include, but are not limited to the following actions: falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records; unauthorized use of Government property, theft, vandalism, or immoral conduct; unethical or improper use of official authority or credentials; security violations; organizing or participating in gambling in any form; and misuse of weapons.

#### 5.4. Notice to the Government of Labor Disputes

The Contractor shall inform the COR of any actual or potential labor dispute that is delaying or threatening to delay the timely performance of this contract.

#### 5.5. Personnel Security

5.5.1 After award of the contract, the Contractor shall provide the following list of data on each employee who will be working under the contract. The Contractor shall include a list of workers and supervisors assigned to this project. The Government will run background checks on these individuals. It is anticipated that security checks will take thirty (30) days to perform. For each individual the list shall include:

- Full Name
- Place and Date of Birth
- Current Address
- Identification number (Cédula de Identidad y Electoral or Passport)

The Contractor shall provide detailed information on all vehicles requiring compound access. For each vehicle, the information shall include:

- Make
- Model
- Year
- Plate Number

Failure to provide any of the above information may be considered grounds for rejection and/or re-submittal of the application. Once the Government has completed the security screening and approved the applicants a badge will be provided to the individual for

access to the site. The Government may revoke this badge at any time due to the falsification of data, or misconduct on site.

The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identity card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the US Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual.

## 6. INSURANCE REQUIREMENTS

6.1 Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

6.2 General Liability (includes premises/operations, collapse hazard, products, completed operations, contractual, independent contractors, broad form property damage, personal injury)

1. Bodily Injury stated in U.S. Dollars:
  - Per Occurrence \$10,000.00
  - Cumulative \$30,000.00
2. Property Damage stated in U.S. Dollars:
  - Per Occurrence \$20,000.00
  - Cumulative \$50,000.00

6.3 The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

For those Contractor employees assigned to this contract who are either United States citizens or direct hire in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- any property of the Contractor,
- its officers,
- agents,
- servants,
- employees, or
- any other person

arising from an incident to the Contractor's performance of this contract. The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

6.4 The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

6.5 Government as Additional Insured. The general liability policy required of the Contractor shall name "the United States of America, acting by and through the Department of State", as an additional insured with respect to operations performed under this contract.

6.6 Time for Submission of Evidence of Insurance. The Contractor shall provide evidence of the insurance required under this contract within ten (10) calendar days after contract award. The Government may rescind or terminate the contract if the Contractor fails to timely submit insurance certificates identified above.

## 7. ACCIDENTS AND INJURY

The Contractor and his employees shall comply with all OSHA regulations and the Dominican Republic's local safety regulations.

The Embassy medical department can be contacted for initial assistance in a medical emergency (during the medical department's normally scheduled hours.)

All OSHA recordable injuries sustained on United States Embassy premises must be reported, in writing, to the Contracting Officer.

## 8. PERMITS

The Contractor shall maintain in full force and effect all permits, licenses, and appointments required for the execution of work under this contract at no additional cost to the Government. The Contractor shall obtain these permits, licenses, and appointments in compliance with host country laws.

## 9. LAWS AND REGULATIONS

Without additional expense to the Government, the Contractor shall comply with all laws, codes, ordinances, and regulations required to perform this work. In the event of a conflict among the contract and requirements of local law, the Contractor shall promptly advise the Contracting Officer of the conflict and of the Contractor's proposed course of action for resolution by the Contracting Officer.



The Contractor shall comply with all local labor laws, regulations, customs and practices pertaining to labor, safety, and similar matters, to the extent that such compliance is not inconsistent with the requirements of this contract.

## 10. INVOICING

The Contractor shall submit monthly invoices via e-mail to the Designated Billing Office (DBO) at the address shown below and send a copy to the COR. The U.S. Embassy of Santo Domingo reserves the right to reject and return incorrect invoices within seven (7) calendar days. The Contractor must then re-submit a corrected invoice. A proper invoice must include the following information:

- Contractor's name and bank account information for payments by EFT
- Invoice Date
- Contract number and/or Task Order Number for Temporary Additional Services.
- A summary showing a listing of each location with its monthly total.
- Prompt payment discount, if any
- Name, title, phone number, and address of person to contact in case of defective invoice

If an invoice does not contain the above information, the U.S. Embassy of Santo Domingo reserves the right to reject the invoice as improper and return it to the Contractor within seven (7) calendars days. The Contractor must then submit a proper invoice.

Payment shall be made in Dominican Pesos (DOP\$) by Electronic Funds Transfer (EFT) within thirty (30) days after receipt of a correct invoice or confirmation of services received. The U.S. Embassy Santo Domingo will provide annual proof of a direct exemption of Value Added Tax (ITBIS); according to host country laws.

The Contractor shall issue separate invoices for any Temporary Additional Services (TAS) and, if applicable, materials, provided and requested under TAS. The Contractor shall also include a copy of the COR's written confirmation, and the task order, for any billed Temporary Additional Services (TAS).

## 12. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

12.1 SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

12.2 STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212-4, Contract Terms and Conditions-Commercial Items), if any of the services exceed the standard.

### 12.3 PROCEDURES.

- (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
- (b) The COR will complete appropriate documentation to record the complaint.
- (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

- (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
- (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
- (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
- (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
- (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

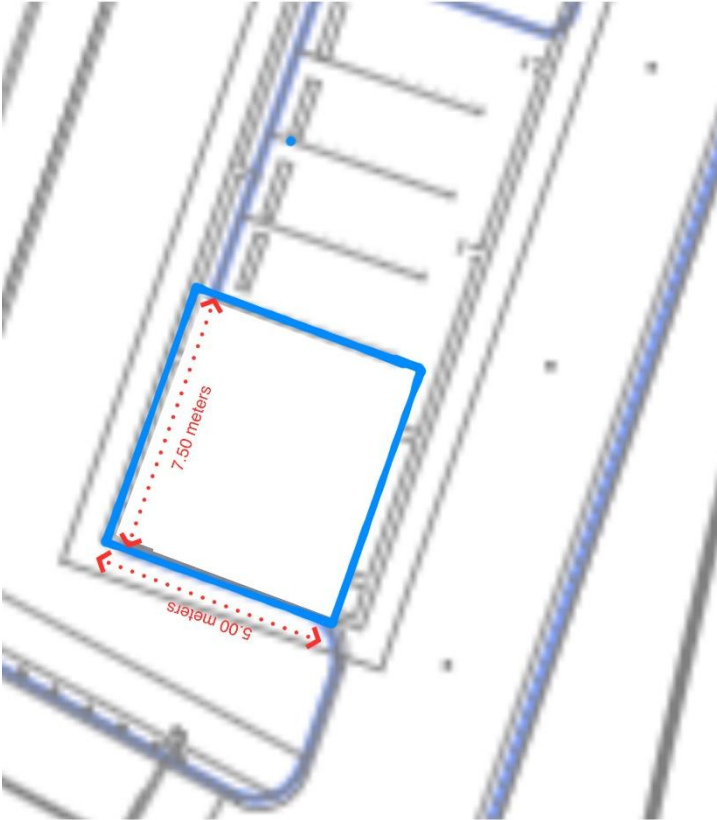
### 1. CHANCERY BUILDING TRANSFER FACILITY.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
